The Board has considered and approved, among others, the Audited Financial Statements of the Bank for the year ended December 31, 2023, and took the related following decisions:

Key Decisions regarding the Ensuing 41st Annual General Meeting (AGM)

a) Recommended Dividend	:	5% Cash and 5% Stock Dividend subject to the approval of Regulatory Authorities and shareholders in the 41 st AGM
b) Record Date	:	23.05.2024 (Thursday)
c) Date of the 41 st AGM	:	30.06.2024 (Sunday)
d) Venue of the AGM	:	AGM will be held virtually using the Digital Platform. The web link for joining the AGM will be communicated in due course through AGM Notice.
e) Time of the AGM	:	3.00 PM

As per BSEC Notification No. BSEC/CMRRCD/2009-193/46/Admin/138 dated October 03, 2022, the following disclosures have been furnished due to the recommendation of 5% Cash and 5% Stock Dividend for the year 2023:

- Stock Dividend has been recommended to strengthen the capital base of the Bank to comply with the regulatory requirements and to support business growth.
- Stock Dividend is declared out of accumulated profit, and
